#### **MAINTENANCE**

All Arctic Finland House products should be used according to the Arctic Finland House product manual (this document). All of Arctic Finland House products are made from natural wood and it is customer's responsibility to protect / paint his / hers product against the weather. All the products should be treated as normal wood houses. Products need to be protected from mold and painted so that they will last longer. Customer should also make sure that product's air circulation is working also during winter time. This means that customer should make sure that replacement air pipes are open all year around and that moisture gets out from the product (through smoke pipe). Customer should also make sure that Arctic Finland House's product's roof is not covered by heavy snow. There shall not be more than 20 cm (depth) snow on the roof and smoke pipe should never be covered by snow nor closed manually. This will cause moisture inside product and mold inside structure.

All replacement parts are readily available at your Arctic Finland House Retailers.

## LIMITED LIABILITY

Arctic Finland House guarantees this product to be free from defects in materials or workmanship to the original consumer. This guarantee is for the periods herein specified when used under normal and reasonable conditions, one (I) year from the date of original purchase. This warranty does not include the cost of property damage or any inconvenience due to the failure of the product. Nor does it cover damage due to misuse, abuse, accident, or damage resulting from transportation of the product. Nor does it include damage resulting from the commercial use of this product. If the product fails to operate due to a defect in materials or workmanship during the warranty period, the defective part will be repaired or replaced at Arctic Finland House's option. ## Dear customer,

We are glad that you have decided in favour of our product.

Please read the assembly manual carefully before proceeding with the house installation! You will thus avoid problems and will not waste time.

#### Recommendations:

- Keep the house package until its complete assembly in a dry place, but not in direct contact with the ground, protected from weather conditions (moisture, the sun, etc.). Do not keep the house package in a heated room!
- When selecting the garden house location, make sure that the house will not be subjected to extreme weather conditions (areas of strong snowfall or winds); otherwise you should attach the house (for instance, with anchors) to the subsoil.

# Warranty

Your house is made from high quality wood and delivered in the natural (unprocessed) form. If, despite our thorough inspection, you should have complaints, please contact to the product seller.

ATTENTION: Please be sure to keep the documentation accompanying the house package!

We can only review complaints if you submit the number of the house to the seller!

## The warranty does not cover:

- Peculiarities of wood as a natural material
- · Wooden details already painted (processed with a wood preservative)
- · Wooden details containing whole branches that do not endanger the stability of the house
- · Colour tone variations caused by wood structure differences that do not influence wood lifetime
- · Wooden details containing (caused by drying) small cracks/gaps that do not pass through and do not influence the structure of the house
- · Twisted wooden details if they can nevertheless be installed
- Roof and floor boards that may have on their concealed surfaces some non-planed areas, colour differences and waning
- Complaints resulting from an incompetent manner of the installation of the house or the house subsiding due to an incompetently made foundation
- Complaints caused by introducing self-initiative changes to the house, such as the deformation of wooden details and doors/windows due to an incompetent manner of wood processing, etc.

The complaints covered by the warranty are satisfied to the extent of replacing the deficient/faulty material. All other demands will be excluded!
